DIRECTIONS FOR USE:

Read Material Safety Data Sheet thoroughly before using this product. Wet the surface to be treated prior to the product application. Apply Landa Graffiti Remover – Metal Saver undiluted, directly onto area being treated using a sprayer, sponge or rag. Always test on a small area prior to product application. Allow 60 seconds for full activation and then lightly scrub with a rag or light scouring pad. Repeat process as necessary then rinse-off treated area with water. Repeat process as needed. May be inappropriate for use on plastic and rubber surfaces.
